# Session Update

The Missouri Legislature convened at noon on Jan. 4. The first week of session is largely ceremonial. The legislators elected leadership, adopted rules and began reading all the pre-filed legislation into the official record.

Because this session marks the start of a new legislative term, both chambers elect leaders to serve for the next two years. Unlike the spectacle in Washington, the process in Jefferson City went smoothly. Here are top legislative leaders for this session:

### Senate

- · President Pro Tem—Senator Caleb Rowden
- · Majority Floor Leader—Senator Cindy O'Laughlin
- · Minority Floor Leader—Senator John Rizzo

### House

- · Speaker—Representative Dean Plocher
- · Speaker Pro Tem—Representative Mike Henderson
- · Majority Floor Leader—Representative Jonathan Patterson
- · Minority Floor Leader—Representative Crystal Quade

Legislators begin pre-filing legislation on Dec. 1. Pre-filing gives bills a slight head start in the process, so most legislators try to pre-file issues they know they want to advance. Once session starts, all this legislation must go through the same process as if it were introduced on the floor. That means that the titles of all the pre-filed bills must be read out loud to enter them into the journal. That process, the adoption of the rules and the swearing in of new members takes up the first two days of session.

This week, legislators will return to Jefferson City on Monday and start the first full week of session. Committee chairs will likely be named, and some bills will be assigned to committees. After that is done, bills will begin to have hearings in committees.

Because this is the start of a new legislative term, there are many new legislators. MOCPA will begin reaching out to these new legislators to acquaint them with us and establish a relationship.
